

This document is a summary of cover highlighting the main features and benefits as well as the general conditions and exclusions of this policy. Full terms and conditions can be found in the policy wording. You will also receive a policy schedule showing the specific details of your policy and the cover(s) you have selected. Please take some time to read the policy documents when you receive them. It is important that you tell us as soon as possible if any of the information is incorrect.

What is this type of Insurance?

This cover will pay vehicle hire costs in the events listed below under “What is insured” provided a claim is in-keeping with the product provisions.



What is insured?

We will arrange and pay for a hire vehicle if your vehicle is:

- ✓ Stolen
- ✓ Or is made undriveable or is a total loss following:
 - ✓ attempted theft
 - ✓ arson
 - ✓ criminal damage
 - ✓ vehicle interference
- ✓ or if your vehicle is declared a total loss by your motor insurer following any of these events.



What is not insured?

- ✗ Motorcycles;
- ✗ Any vehicle hire costs incurred before we have accepted your claim;
- ✗ Any claim which does not result in an accepted and paid claim for the event by your motor insurer;
- ✗ Any claim resulting from theft or vandalism which has not been reported to the Police;
- ✗ Any claim relating to theft from your vehicle;
- ✗ Any claim where your vehicle suffers a mechanical or electrical breakdown;
- ✗ Any claim where your vehicle was being used as an emergency vehicle, or in a race, competition, rally or trial at the time of the insured incident;
- ✗ Any claim where you are disqualified from driving;
- ✗ Any claim where you have incurred two or more periods of disqualification or any conviction with a period of disqualification of six months or more, within the last five years;
- ✗ Any claim where the driver of your vehicle does not hold a valid driving licence or is under the influence of drink or drugs, at the time of the insured incident



Are there any restrictions on cover?

- ! You are covered for a maximum of 2 claims during the period of cover (The Cover).
- ! We will only pay the cost of hiring a vehicle for a single period up to the number of days as specified on your Certificate of Insurance or until your vehicle can be driven again if this is sooner. (Definitions, Vehicle hire costs).
- ! We will not pay for any fuel, fares, fines, penalties or fees relating to the hire vehicle whilst in your possession.
- ! Your vehicle must be undriveable.
- ! We will not provide a hire vehicle where you can be provided with a replacement vehicle via the approved repairer courtesy car program arranged by your insurer and their repairer network or where you can be provided with a replacement vehicle via an alternative



Where am I covered?

- ✓ Cover is offered for The United Kingdom of Great Britain and Northern Ireland



What are my obligations?

You must provide full and accurate information to all questions asked. Your answers must be true to the best of your knowledge and belief. Your answers will form part of the statement of facts on which your policy will be based. If you become aware that information you have given us is inaccurate or has changed, you must inform us as soon as possible. Failure to do this may invalidate your policy and claims may not be paid.



When and how do I pay?

Your broker will discuss the premium payment method with you.



When does the cover start and end?

Your cover will start and end on the dates stated in your policy documents.



How do I cancel the contract?

If you decide that for any reason, this policy does not meet your insurance needs then please return it within 14 days from the date of purchase or the day on which you receive your policy documentation, whichever is the later. On the condition that no claims have been made or are pending, the premium will be refunded in full. If you wish to cancel after the 14 day cooling off period, please contact the organisation from whom you bought your policy.

What happens if we can't meet our liabilities?

Great Lakes Insurance SE is covered by the Financial Services Compensation Scheme (FSCS). You may be entitled to compensation from the scheme, if it cannot meet its obligations.
